Privacy and sensitive data statement (European Regulation 2016/679 27 April 2016 and following edits)

Within the meaning of Article 13 of the European regulation concerning personal data protection we inform you that the at Scuola dell'Infanzia "Monumento ai Caduti." in Via Roma 19–Quinto Vicentino (VI), data controller, personal data of pupils and of their relatives, as well as those concerning sensitive mental and physical data and related to religious beliefs will be used. This use of personal data will be directed solely to the management of the requested service, as well as to the educational and formative actions and to the administrative issues, and it will be performed also through IT tools, within the necessary limits suitable for pursuing those tasks. The privacy and safety of the collected data will be guaranteed.

Data might be communicated, according to the in force regulations and within the authority, to the School Authorities and to other bodies entitled by law or by regulation, to local health boards, involved Public Bodies, public or private subjects who collaborate to the school activities, transport and catering companies, Insurance Companies with which insurances have been stipulated and, upon a specific request, to other schools which pupils might be transferred to. Pupils' personal data might be communicated to museums secretaryships, exhibitions and other subjects which may request them during guided visits or school trips. Internal or external personnel entitled for the use of personal data, either employed, collaborators or external bodies, may access the personal data.

Bestowal of data is mandatory in order to access the requested services and failing to do so will automatically prevent carrying out them. Personal data will not be transferred or communicated to third Countries or to International organizations external to the European Community.

Personal data will be kept for a period no longer than that necessary for carrying out the aims for which data are collected and used, anyway always within the respect of the filing terms established by the in force regulations.

The rights established by the mentioned Regulation are recognized to the involved subjects and specifically:

- the right to access to one's own personal data, to request adjustment of them, update and cancellation, if incomplete, wrong or collected by violating the Law, as well as to take a position against their use for legitimate reasons
- the right to withdraw the consent in any moment without compromising the lawfulness of the performed use before the revocation
- the right of data portability
- the right to complain to controlling authorities
